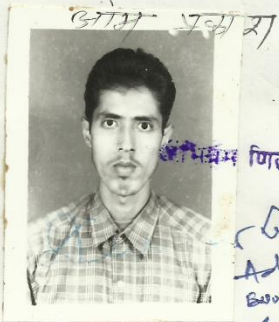

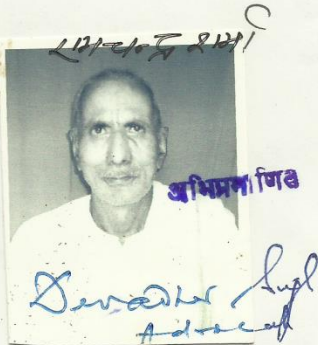

- (e) To employ staff and to allow the establishment expenses to be incurred for the purpose of carrying out the objects of the Trust.






